

NOTICE INVITING TENDER

1. Online e-tenders are invited by General Manager-Tech., SCOPE on behalf of Constituents of SCOPE MINAR, Laxmi Nagar Delhi- 110092 for the following work as per the detail given below:-

1.1 Name of the work : **ARC for Cleaning of water storage tanks, Sump Pits and open drain channels at SCOPE Minar, Laxmi Nagar District Centre, Delhi.**

1.2 Estimated Cost : Rs. 5,17,004.00 per annum
incl. GST @ 18%

1.3 Earnest Money : Rs. 11,000/-

1.4 Tender Processing fee : Rs. 590/-

1.5 Duration of Contract : Two Years from the date of issue of LOI.

Bidders have to download the Bid documents from the e-procurement portal i.e. www.tenderwizard.com/SCOPE after registering themselves on portal and submit e-bids after payment of bid processing fee & Bid document fee before last date & at time of downloading the e-bids online. Bidder can also view the NIT, scope of work on www.scopeonline.in. For E-tendering support:- 8800991840, 8800991868.

3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.
4. Tender document shall be accepted only from reputed, specialized Contractors in the similar field working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE/Private sector who fulfill following pre-qualification criteria producing their original documents in this regard:
 - 4.1 Experience of having successfully completed similar works during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed works of aggregate cost not less than the amount equal to 80% of the estimated cost.

“Similar works shall mean “Cleaning of water supply, sewer water tanks and open drains in multi-storied office building & industry”.
 - 4.2 The past experience should be supported by certificates issued by clients organization. In case of experience of pvt. Sector, the completion certificate shall be supported with copies of letter of award and copies of corresponding TDS certificate. The value of work shall be considered equivalent to the amount as shown in the TDS certificate.
 - 4.3 The Tenderer must be registered with GST & Income Tax act and should have PAN number, PF, ESI registration. Copies of registration papers along with details need to be furnished with latest challan.
 - 4.4 Hard copy of Form of Tender duly signed & stamped must submitted along with tender cost and EMD.
5. All the above certificate / documents shall be uploaded by the firm duly signed & self attested subject to verification with original documents.
6. The tender shall be submitted: thorough only e-portal i.e. [www. tenderwizard.com](http://www.tenderwizard.com) / SCOPE.
7. Tenderers are advised to submit their offers strictly based on the layout, design parameters, specific requirements, terms & conditions and specifications given in the tender documents and instructions to the bidder.

8. Cost of tender documents & Earnest money mentioned above should be paid by crossed Demand Draft/Pay orders from any nationalized /Schedule Bank in favor of "MMO SCOPE Minar". Tenders without cost of tender and Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.

SCOPE OF WORK

The Scope of work shall, inter alia, include the following:

SCOPE Minar has been provided with 8 nos. of over head tank, 8 nos. of underground tank , 9 nos. sump pits and open channels (In the basements). Details are mentioned at Page no. 27 of this tender. Scope of work includes:-

1. The inside of the tanks shall be scrubbed with jute brushes without damaging the surface of the tanks. For cleaning of tanks washing powder and bleaching powder shall be used. After satisfactory cleaning of the tanks, they shall be disinfected using Potassium permanganate (KMNO₄).
2. The sludge / garbage collected from these tanks, pits etc., shall be shifted to the nearest dumping area of MCD.
3. The cleaning schedule will be framed in such a manner so that the water supply is not interrupted to any of the constituents in the North & South Tower of SCOPE Minar.
4. Total responsibility of cleaning , disinfecting , loading, unloading and shifting of garbage, supervision of all the above works will be of the agency over and above arranging required manpower , tools , tackles , torch light , leader , hand lamp and consumables as per the work requirement.
5. Proper site clearance after completion of work and during the progress of work as per instructions of Engineer In-Charge.
6. Supply & application of all the consumables.
7. This work is to be executed on turnkey basis and any item not specifically mentioned in the scope of work or Bill of Quantity (BOQ) is deemed to be included in the overall value of contract.
8. The duration of this ARC (Annual rate Contract) will be two years from the date of LOI. During this period rate agreed, shall be firm and no escalation / increment shall be paid on any account. The contract may further be extended for one year i.e. to 3rd year based on the satisfactory performance of the contractor for which rates shall be revised as mutually agreed by the SCOPE and the contractor.
9. The work shall be executed as per schedule given by the department and the department may also schedule cleaning of a particular tank, sump pits or open drain channels as per site requirement. The contract will required to execute the same as per instructions of the EIC on the rate finalized for that particular item.
