- 2. Three similar civil jobs successfully completed, each costing not less than the amount equal to 40% of estimated cost put to tender during last seven years.

Two similar jobs successfully completed, each costing not less than the amount equal to 60% of the estimated cost put to tender during last seven years.

One similar job successfully completed of aggregate cost not less than the amount equal to 80% of the estimated cost put to tender during last seven years.
