6. The bidder should have a turnover not less than threecrore annual during the last two years period. Documentary proof for the same is to be submitted duly certified by CA.

7. The bidder must have five years of experience of printing monthly magazine of minimum 60 pages of government department/PSUs/Autonomous Bodies. The bidder should provide work order and completion certificate
