Bidder have to download the Bid documents from the e-procurement portal i.e www.tenderwizard.com/SCOPE after registering themselves on portal and submit e-bids after payment of bid Tender processing fee & Cost of Tender documents, before last date & time of downloading the e-bid online. Bidder can also view the NIT, scope of work on www.scopeonline.in. for E-tendering support 8800991840,8800991868
3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.

4. Tender document shall be accepted only from reputed specialized contractor/manufactures, who full fill following pre-qualification criteria & showing their original documents in this regard:

Experience of having successfully completed works during the last 7 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works costing not less than the amount equal to 60% of estimated cost put to tender.

OR

One similar completed work costing not less than the amount equal to 80% of estimated cost put to tender.

and

- a. One Completed work of any nature(either part of(3) or a separate one) costing not less than the amount equal to 40% of the estimated cost put to tender with some Central Government Department/State Government Department/Central autonomous Body/State Public Sector Undertaking/SCOPE/city Development Authority/Municipal Corporation of City Formed under any Act by Central/State government and published in Central/State Gazette.

“Similar works shall mean “Renovation works i.e. Granite / Tiles works in multi- storeyed office building & industry”.

- b. The past experience in similar nature of work should be supported by certificates issued by the client’s organization. In case the work experience is Private sector the completion certificate shall be supported with copies of Letter of Award and copies of Corresponding TDS Certificates. Value of work will be considered equivalent to the amount as shown in TDS Certificates.
- c. The Tenderer must be registered with GST & Income Tax act and should have PAN No.Copeis of registration papers along with details need to be furnished with latest challan.
- d. Form of Tender duly signed & stamped must submitted during submitting of tender through e-portal.
- e. Copies of similar works executed / in hand for multi-storied office building & industry during last five years along with work order & clients performance certificate.
5. All the above certificate / documents shall be uploaded by the firm duly signed & self attested subject to verification with original documents.
6. The tender shall be submitted: through only portal i.e www.tenderwizard.com/SCOPE.

7. Tenderers are advised to submit their offers strictly based on the terms & conditions and specifications given in the tender document and instruction to bidder.
8. Cost of Tender document & Earnest Money mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favor of **"MMO SCOPE MINAR"**. Tenders without cost of Tender and Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.
9. SCOPE reserves the right to reject any or all tenders without assigning any reasons.

SCOPE OF WORK

The Scope of work shall, inter alia, include the following:

To execute to the work as per items mentioned in the schedule of only as per CPWD DSR & other relevant specification and market rates.

The work is to be executed in an occupied building where PSU offices are functioning. Hence, work shall be done in a proper manner with minimum disturbance to the working environment of the building. The rate to be quoted for each item & for all leads, lifts at the above mentioned places in SCOPE Minar. Nothing extra shall be payable.

The contractor should carry out the work with utmost care to as to not disturb/dispute/damage the interiors done by various constituent PSUs of the building.

1. The disposal of removal material shall be done in a systematic manner away from The grounds of SCOPE Minar and it shall not be allowed to accumulate.
2. Dismantled portions become most vulnerable places till Renovation of Pantry at different floor is carried out.
3. Supply & application of all the consumables complete in all respect.
4. Proper site clearance after completion of work and during the progress of work as per instructions of Engineer-in-Charge.
5. Dismantled surplus material should be dispose off from the site to stores of SCOPE as per directions of Engineer-In-Charge.
6. After completion of work and during progress of work, proper site clearance should be done as per the directions of Engineer-In-Charge.
7. Supply & fixing of all the materials required to carry out the work including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.
8. As this work is to be carried out in locations where offices of the constituents of SCOPE Minar are functioning, contractor has to work in such manner that constituents face minimum disturbance. For this purpose contractor may have to work in late hours or after office hours or on holidays including Sundays etc.
9. The work shall be carried out in such a way that no damage to the property of SCOPE/Building occurred and in case of any damage to the same contractor is liable to replace/provide the same.
