SCOPE OF WORK

The scope of work includes the following:-

- 2. Dismantling, removing & shifting of existing damaged fire hose reel drum sets from fire hydrant risers including consumables i.e. welding electrodes, oxygen, acetylene gas, all taxes etc. complete in all respect as per directions of Engineer-In-Charge.
- 3. Installation, Testing & commissioning of fire hose reel drum sets on fire hydrant risers including consumables i.e. welding electrodes, oxygen, acetylene gas, accessories i.e. GI clamps, nut & bolts, all taxes etc. complete in all respect as per directions of Engineer-In-Charge.
- 4. Buy back of existing dismantled fire hose reel drum sets
- 5. Scope of work also includes the cost of making cutouts for installation of hose reel drum sets, if required at site.
- 6. Proper level & height of first aid fire hose reel drums to be achieved by the contractor.
- 7. Supply & laying / fixing / installing of all the materials required to carryout above said works, job including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.
- 8. As works are to be carried out in locations where offices of the constituents of SCOPE Minar are functioning, contractor has to work in such manner that constituents face minimum disturbance.
