3. Tender document shall be issued only to specialized Contractors / Manufactures working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies who fulfill following pre-qualification criteria:

3.1 Proof of registration with, Service Tax, VAT clearance certificate & PAN No.

3.2 Experience of having successfully completed works for Fire Protection / PA/Digital Security System during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed work of aggregate cost not less than the amount equal to 80% of the estimated cost.

4 **The tender shall be submitted in the following manner, in two separate sealed envelopes, duly superscribed the name of work alongwith following details:-**

Envelope-I “EMD”

Envelope-II “Technical and priced Commercial Bid”

Envelope – I shall contain ‘EMD’. Envelope-II shall contain tender containing Technical & priced Commercial Bid duly signed and stamped on all pages. It is to be noted that the sealed envelope containing tender documents (Envelope-II) shall contain only the prices without any conditions whatsoever.

5 Tenderers are advised to submit their offers strictly based on the design parameters, Specific requirements, terms & conditions and specifications given in the tender document.

6 Earnest Money mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favour of **“MMO SCOPE Minar”**. Tenders without Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.

7 The Bids shall be opened on the due date in the presence of tenderers or their authorized representatives who wish to remain present.

Scope of work

General Description of existing P.A system which is of PHILLIPS make installed in Core 1 UL Floor is spreads out to all the common areas, offices consisting of following:-

Amplifiers (LBD 8148)	:	05nos. for Speakers 03nos. for Car Polling
Master Amplifier	:	02 nos.
Deck	:	02 nos.
Zonal Panel	:	02 nos. (18 Zones) 02 nos. (23 Zones)
Speakers	:	300 nos.

Bidders to study the existing installed PA system and confirm the details, the above details are mainly for guiding the bidder.

The Scope of Work under this contract is for Replacement of existing PA System with newly / Upgraded PA Facilities at SCOPE Minar.

The scope of work covers design, supply, delivery, installation, testing & commissioning of the Public Address System shall include, but not limited to the following:

1. It is proposed to retrofit the current installation based on the current occupancy and interior of the buildings..
 2. The existing wiring shall be traced and any broken loop found shall be re-connected with new wiring.
 3. Once loop is traced all speakers as installed and missing shall be replaced with new speakers.
 4. Integration of FAS with Proposed PA System shall be including in the scope of work.
 5. Termination of all cables to speakers, power amplifiers, Main equipment and all associated equipments etc. as reqd;
- All other works and materials necessary for the efficient operation of the whole audio system Complete with power supply requirements and surge arrestors and filters etc as reqd.
