## **SCOPE Of work**

- 1. Dismantling of G.I pipe lines(25mm to 150mm) along with fittings and clamp, union etc and disposing unserviceable material with the premises of SCOPE Minar As per direction of Engineer-in-charge and staking of serviceable martial within SCOPE minar reaffixing of same with fitting viz flange nut bolts,tee,elbow bends etc complete.
- 2. Providing and fixing 20mm to 150 mm dia nominal bore Gate valve of ZOLOTO make with Complete .
- 3. Providing and fixing 25mm to 150mm nominal bor G.I pipe line of Jindal Hissar make heavy class including all fitting such as socket, Tee elbow nipple etc as per complete the job with synthetic enamel paint of approved brand and manufacture paint over ready mixed priming coat nerolac, asian (All fitting shall be of ISI make)
- 4. Testing and commissioning of newly installed PRV station including the cost of setting the pressure of water out let pressure to required level with the help of pressure gauges and including the cost of all consumable i.e taflon taps etc,tools & plants transportation etc complete in the all respect. Pressure gauges and all accessories for pressure testing pressure setting etc arrange by the contractor at own cost.
- 5. Dismantled surplus material should be dispose off from the site to stores of SCOPE as per directions of Engineer-In-Charge.
- 6. After completion of work and during progress of work, proper site clearance should be done as per the directions of Engineer-In-Charge.
- 7. Supply & fixing of all the materials required to carry out the work including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.
- 8. As this work is to be carried out in locations where offices of the constituents of SCOPE Minar are functioning, contractor has to work in such manner that constituents face minimum disturbance. For this purpose contractor may have to work in late hours or after office hours or on holidays including Sundays etc.
