1. Sealed item rate tenders are invited by Dy. General Manager – Engg., SCOPE on **behalf of Constituents of SCOPE Minar**, Laxmi Nagar, Delhi-110092 for the subject work as per the details given below.
 - 1.1 Name of the work : **Provision of Shed over walkway (3rd phase) around SCOPE Minar, Laxmi Nagar, Delhi-92.**
 - 1.2 Estimated Cost : **Rs. 13,76,703.00 plus GST**
 - 1.3 Earnest Money : **Rs. 33,000.00**
 - 1.4 Time for completion : **Sixty (60) Days from the date of issuance of LOI**
 - 1.5 Cost of Tender : **Rs. 500.00**

Tender documents consisting of Technical specifications, schedule of quantities, contract conditions, can be had from the office of Dy. General Manager-Engg., MMO, SCOPE Minar, Laxmi Nagar, Delhi-110092 on payment of Rs. 500.00/- in the form of Draft in favour of “MMO SCOPE Minar” (Non-refundable) on any working day **from 07.08.2018 to 20.08.2018** during working hours from 10.00 A.M. to 4.00 P.M. Scope of work & Eligibility criteria can also be seen from the website of SCOPE: www.scopeonline.in. However, Bid shall be submitted on purchased documents only.

- 3 Tender document shall be issued only to reputed, specialized Contractors working with CPWD / PWD / MES / Railways / Govt. Undertakings / Autonomous bodies / SCOPE, qualifying the following criteria:
- 3.1 Three similar / Civil works, each costing not less than the amount equal to 40% of estimated cost put to tender in the last five years.
- OR
- Two similar / Civil works, each costing not less than the amount equal to 60% of the estimated cost put to tender in the last five years.
- OR
- One similar / Civil work of aggregate cost not less than the amount equal to 80% of the estimated cost put to tender in the last five years.
- 3.2 The Tenderer must be registered under ESI, PF, GST & income tax act and should have PAN No. Copies of registration papers along with details need to be furnished.
- 3.3 All the above certificate / documents shall be submitted by the firm duly signed & self attested subject to verification with original documents.
- 3 Submission of Tender: The Earnest Money Deposit shall be submitted in one envelope and the duly filled tender shall be submitted in the other envelope. These two envelopes shall be submitted under one sealed envelope super scribing the NIT no. and the name of work. The tenders without EMD shall not be opened
5. Tenders are invited to submit their offers strictly based on the terms & conditions and specifications given in the tender document.
6. Earnest Money mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favour of “MMO SCOPE Minar”. Tenders without Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.
7. SCOPE reserves the right to reject any or all tenders without assigning any reasons.

SCOPE OF WORK

In this contract, provision of shed is to be made as per existing design & specifications over walkway around SCOPE Minar from Grid no. 24 up to RCC slab near Grid No.30. The scope of work includes the following:-

- a. Removal of existing stone from walls of planters to fix vertical members of shed as required shall be included in the scope of work.
- b. Supply & installation of MS plates of various thickness i.e. 12mm, 10mm, 8mm, 5mm etc., 12mm Hilti dash fasteners, MS Cleats and any other accessories required to complete the work as per drawings enclosed as Annexure-A is included in the scope of work. Nothing shall be paid extra on this account.
- c. Supply fabrication & installation of new MS hollow tubes as per DSR 2016 item no. 10.16.2 and accessories as per requirements at site. **Machine bending of the members as per drawing attached as Annexure-A** is required to achieve to give a elegance look to the structure.
- d. Painting of sheds with synthetic enamel paint of approved brand and manufacturer to give an even shade, two or more coats on new work including applying priming coat with ready mixed red oxide zinc chromate primer of approved brand and manufacturer on steel work complete in all respect and as per directions of engineer In-Charge.
- e. After completion of work and during progress of work, proper site clearance should be done as per the directions of Engineer-In-Charge.
- f. Proper level of shed is to be achieved by the contractor.
- g. Supply & fixing of all the materials required to carryout the work including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.
- h. Contractor shall get approved the sample of materials before supply at site.
- i. As this work is to be carried out in locations where offices of the constituents of SCOPE Minar are functioning, contractor has to work in such manner that constituents face minimum disturbance. For this purpose contractor may have to work in late hours or after office hours or on holidays including Sundays etc.
- j. The contractor have to work in late hours or after office hours or on holidays including Sundays etc. Decision of Engineer-In-Charge in this regard will be final and contractor is bound to carryout the work accordingly, other wise suitable penalty shall be imposed on the contractor.
- k. The work shall be carried out in such a way that no damage to the property of SCOPE / Building occurred and in case of any damage to the same contractor is liable to replace / provide the same.
