- 2. Bidders have to download the bid documents from the e-procurement portal i.e. <a href="https://www.tenderwizard.com/SCOPE">www.tenderwizard.com/SCOPE</a> after registering themselves on portal and submit e-bids before the last date and time of downloading the e-bids online. Bidder can also view the documents on <a href="https://www.scopeonline.in">www.scopeonline.in</a>
- 3. The bidder must be registered under GST. Copies of registration papers along with details need to be furnished. The bidder should have a turnover not less than two crores annual during the last two years period.
- 4. The bidder should have successfully delivered/supplied similar work in any PSU/or other reputed organizations and should provide the credentials.
- 5. Unconditional letter of acceptance of Bid conditions and specifications must be submitted duly signed and stamped during submitting of Bid through e-portal.
- 6. All the above certificate/documents shall be submitted by the firm duly signed and self attested subject to verification with original documents.
- 7. The rates and amount shall be quoted both in words and in figures.
- 8. The rates shall be inclusive of all taxes, duties and cartage etc.
