4. Tender document shall be accepted from the specialized Contractors / Manufactures working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/ SCOPE who fulfill following pre-qualification criteria & showing their original documents in this regard:

- 4.1 Proof of having successfully completed similar works during the last 5 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar completed works, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar completed works of aggregate cost not less than the amount equal to 80% of the estimated cost put to tender.

4.2 The tenderer must be registered under ESI, PF, GST & Income Tax act and PAN No. Copies of registration papers along with details need to be furnished. Latest ESI & PF deposit with challan is also needed.

**4.3 Hard Copy of Form of tender duly signed & stamped must submitted alongwith Tender Cost & EMD.**

## SCOPE OF WORK

The SCOPE Minar is a state of art office building located at Laxmi Nagar District Centre, Delhi-92 comprising of twin tower namely North Tower & South Tower. North Tower is G+ Mezz. +20 floor and South Tower is G+Mezz. +15 floor where in space is reserved for offices of various Govt. of India Enterprises. The building is Centrally Air conditioned and has power back up through 4Nos. X1010 KVA water cooled DG sets installed at Sub-station at Ground floor. The 4 Nos. cooling towers of 100TR capacity each along with end suction centrifugal pumps & remote isolator panel are installed at podium level (3<sup>rd</sup> floor) of the building for DG Sets cooling water system. It is intended to replace all the four cooling water pumps, in & out pipes, valves, NRVs, pressure gauges & remote isolator panel. The cooling water shall be installed at podium level (3<sup>rd</sup> floor). In /out, pipe of these pumps are to be connected to the existing main piping headers.

The Scope of work shall, inter alia, include the following:

1. Dismantling & buy back of existing pumps and its associated valves, NRVs, flanges etc.
2. Repair of foundation of as per GA drawing provided by Manufacturer of the pumps including supply of all materials complete in all respect as per requirement of GA drawings & specifications.
3. Supply, installation, testing & commissioning of pumps, M.S ERW pipes, Valves, NRVs including flanges, Nut & Bolts,, gaskets, pipe supports and all consumables like electrodes, oxygen acetylene etc required for the entire work.
4. Painting of supports, piping etc.
5. Supply, installation, testing & commissioning of remote isolator panel and its termination with existing power & control cable, lugs, thimbles, earthing etc complete in all respect as required for the work and as per specification, BOQ etc.
6. Proper site clearance after completion of work and during the progress of work as per instructions of Engineer In-Charge.
7. Scope of work also includes the all the consumables required to carryout the work.
8. This work is to be executed on turnkey basis and any item not specifically mentioned in the scope of work or Bill of Quantity (BOQ) is deemed to be included in the overall value of contractor.
