Bidder can also view the NIT & Scope of work on [www.scopeonline.in](http://www.scopeonline.in).

- 3 Bids shall be submitted through e-bidding mode only. No other mode of Bid submission shall be accepted.
4. Tender document shall be accepted only from reputed specialized contractors who are working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria & showing their original documents in this regard:

Experience of having successfully completed works during the last 7 years ending previous day of last date of submission of tenders.

4.1 Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender.

OR

4.2 Two similar completed works costing not less than the amount equal to 60% of estimated cost put to tender.

OR

4.3 One similar completed works costing not less than the amount equal to 80% of estimated cost put to tender.

**“Similar works shall here mean Kitchen ventilation work in multi-storeyed office building & industry”.**

- 5.0 The Tenderer must be registered under GST & income tax act , ESI, PF and should have PAN No. Copies of registration papers along with details need to be furnished latest ESI & PF deposit with challan authority is also needed.
- 6.0 Forms of Tender duly signed & stamped must be submitted during submitting of tender through e-portal.
- 7.0 All the above certificate / documents shall be uploaded by the firm duly signed & self attested subject to verification with original documents

- 9.0 Tenderers are advised to submit their offers strictly based on the layout, design parameters, specific requirements, terms & conditions and specifications given in the tender document and instruction to bidder.
