Online e-tenders are invited by Dy.General Manager (Engg.) SCOPE on behalf of Constituents of SCOPE MINAR, Laxmi Nagar Delhi- 110092.For the subject work as per the details given below:

- 1.1 Name of the work : **Water proofing treatment on south and North tower Terrace at SCOPE Minar .**
 - 1.2 Estimated Cost : Rs.18,62,368/-inclusive GST @ 18%.
 - 1.3 Earnest Money : Rs.38000/-
 - 1.4 Tender Processing fee : Rs.1648/-
 - 1.5 Time for completion : Three Months from the date of issue of LOI.
 - 1.6 Cost of Tender : Rs.560/-

Bidder have to download the Bid documents from the e-procurement portal i.e www.tenderwizard.com/SCOPE after registering themselves on portal and submit e-bids after payment of bid Tender processing fee & Cost of Tender documents, before last date & time of downloading the e-bid online.  3. Bids shall be submitted through e-bidding mode only. No other mode of bid submission shall be accepted.

4. Tender document shall be accepted from reputed, specialized Contractors/Manufactures in the similar field working with CPWD/PWD/MES/Railway/PSUs/Autonomous Bodies/SCOPE who fulfill following pre-qualification criteria producing their original documents in this regard :

4.1 Experience of having successfully completed works during the last 7 years ending last day of the month previous to the one in which applications are invited:

Three similar work completed orders, each costing not less than the amount equal to 40% of estimated cost put to tender.

OR

Two similar work completed orders, each costing not less than the amount equal to 60% of the estimated cost put to tender.

OR

One similar work completed orders of aggregate cost not less than the amount equal to 80% of the estimated cost.

4.2 The Tenderer must be registered with GST & Income Tax act and should have PAN No. Copies of registration papers along with details need to be furnished with latest challan.

4.3 Form of Tender duly signed & stamped must submitted during submitting of tender through e-portal.

5. All the above certificate / documents shall be uploaded by the firm duly signed & self attested subject to verification with original documents.

6. The tender shall be submitted: through only portal i.e www.tenderwizard.com/SCOPE.

7. Tenderers are advised to submit their offers strictly based on the terms & conditions and specifications given in the tender document and instruction to bidder.

8. Cost of Tender document & Earnest Money mentioned above should be paid by crossed Demand Draft / Pay order from any Nationalized / Scheduled Bank in favor of "MMO SCOPE MINAR". Tenders without cost of Tender and Earnest Money Deposit will be summarily rejected and the representative of such tenderers will not be allowed to attend tender opening.

9. SCOPE reserves the right to reject any or all tenders without assigning any reasons.

Scope Of work

The Scope of work shall, inter alia, include the following:

To execute the work as per items mentioned in the schedule of only as per CPWD DSR & other relevant specification and market rates.

The work is to be executed in an occupied building where PSU offices are functioning. Hence, work shall be done in a proper manner with minimum disturbance to the working environment of the building. The rate to be quoted for each item & for all leads, lifts at the above mentioned places in SCOPE Minar. Nothing extra shall be payable.

The contractor should carry out the work with utmost care to as to not disturb/dispute/damage the interiors done by various constituent PSUs of the building.

1. The disposal of removal material shall be done in a systematic manner away from The grounds of SCOPE Minar and it shall not be allowed to accumulate.
2. Dismantled portions become most vulnerable places till Water proofing treatment of South tower and North tower trolley track at SCOPE Minar Laxmi Nagar work complete.
3. Supply & application of all the consumables complete in all respect.
4. Proper site clearance after completion of work and during the progress of work as per instructions of Engineer-in-Charge.
5. After completion of work and during progress of work, proper site clearance should be done as per the directions of Engineer-In-Charge.
6. Supply & fixing of all the materials required to carry out the work including all consumables are also in the scope of work of contractor. Nothing shall be paid extra on this account.

Note-: All the above items are to be executed at various roofs of SCOPE Minar as elaborated. The rate quoted by the contractor shall be deemed to include for all the activities labour, materials, machineries, tools and plants required for the satisfactory execution of work for all leads and lifts. Nothing extra shall be payable. The contractor must ascertain himself with the site conditions, nature of work disposal routes etc. before quoting for the work.
