**Subject: SCOPE Eminence Awards 2019-20**

As SCOPE continues to strive for new endeavours and initiatives to strengthen the Public Sector, we also recognise the imperative of honouring the outstanding contribution of the Public Sector Enterprises (PSEs) and their leaders to the economy at large. In this regard, SCOPE had earlier instituted "SCOPE Excellence Awards" and "SCOPE Meritorious Awards" which were well received by the Public Sector fraternity. However, given the dynamic shift in business environment, change in paradigms, global exposure of the Public Sector and increased focus on good governance and ethics, SCOPE has revisited the earlier instituted awards and subsumed them to launch "SCOPE Eminence Awards" for the assessment year 2019-20.

The SCOPE Eminence Awards are instituted with an aim to recognize the performance, contribution and achievements of PSEs as well as their Leaders towards the development and growth of their enterprises along with their contribution in specialised fields. The SCOPE Eminence Awards seeks to not only recognise the performance and achievements of the PSEs in light of the contemporary Indian regulations, but will also apply universal yardstick of corporate governance and performance expected of global companies. The Awards will also take due cognizance of stellar initiatives undertaken by the PSEs under the guidance of their Leaders resulting in improved operating standards and customer expectations in the industry.

The SCOPE Eminence Awards will be presented in 9 categories having 16 specific awards. Also, since SCOPE Eminence Awards are corporate level awards and not for an unit, it is requested to submit entry for each award after consolidating information of all the units at the respective corporate office. **The last of date of receipt of entries by SCOPE Secretariat is Monday, the 18<sup>th</sup> January, 2021.** Nomination received after the last date shall not be considered.

For the first time, as part of its digital initiative, SCOPE is inviting participation by the PSEs on our website [www.scopeonline.in](http://www.scopeonline.in). Participating PSEs may submit their entries on [http://www.scopeonline.in/SCOPE\\_Eminence\\_Awards\\_2019\\_20.php](http://www.scopeonline.in/SCOPE_Eminence_Awards_2019_20.php) and also send two copies of the completed Performa (enclosed) in a Pen Drive along with other relevant documents necessary to substantiate their meritorious performance.

SCOPE shall hold an orientation meeting for the Nodal Officers representing the PSEs where all aspects of making entries into the awards shall be explained. **The half day orientation virtual meeting is scheduled to be held at 3.30 PM on Friday, 18<sup>th</sup> December, 2020.** Link for the same shall be shared subsequently.
